## **TREASURERS REPORT-**

#### **Financials**

A balance of £22,711.39 was reported.

Contingent liabilities totalled £3,081.60 made up of PQS scheme £1,910, 2015 15's prize vouchers £900, and women's cricket unspent budget £271.60.

## **Awards Evening**

It was reported that a loss of £73.10 was anticipated for the evening once outstanding ticket money totalling £168 had been received and the printing bill of £460 paid.

#### Insurance

It was reported that insurance for cups and trophies had been increased to £10,000 at an additional premium of £57.06.

## **UMPIRES COORDINATOR**

It was reported that 34 umpires had attended the annual refresher evening at Stokesley CC on Tuesday 23<sup>rd</sup> February.

Correspondence had been received from the Yorkshire ACO pointing out the need for umpires to be insured. As all NYSD panel members have to be members of the ECB ACO which carried insurance cover no further action was required other than the U-C having in place the requisite monitoring system to ensure all umpires used were in current membership.

The president pointed out there had been reference to a TCS workshop being available locally for scorers and if so it was desirable this opportunity was pursued.

The general secretary would follow this up by obtaining details.

# **LEAGUE GROUNDSMANS ASSOCIATION**

The president reported that Mr Toulson had attended the YGA Committee meeting in Leeds as the NYSD representative.

## **WOMENS AND GIRLS CRICKET**

The possibility of a Yorkshire v Durham women's T20 game being played as a pre-cursor to the NYSD v Yorkshire Vikings on the 29<sup>th</sup> June was being explored as it was felt this would provide an excellent opportunity to promote the women's game in the region. Yorkshire had agreed to provide a development team, and a response was now awaited from Durham.

The potential for forming a League girls u15 team was still being investigated with possible opponents being sought.

Steve Donlan, chair of the Women's committee, suggested that use might be made of the funds available to the committee by supporting an open day at Marton who are making positive strides towards being a satellite club in the region for women's cricket.

Resolved: Proposal supported.

## **LEAGUE WEBSITE**

Jon Buxton had been hired to assist with the construction of the new League Pitchero website at a cost of £200. It should be noted that the League's play-cricket site would still operate and there would be no difference in how club's operated their own inputs.

Representatives of DBS had been entertained by the president at York at the launch of the Yorkshire Premier League championship.

## **Teesside University**

The president had visited the University on two occasions since the last meeting to build relationships with the new League contacts. As a result of those meetings it was hoped to organise a visit of the Yorkshire CCC CEO to the University in April to further cement relationships.

#### **TAG Teamwear**

The president had held a meeting with Mr Fothergill and a further one year's support package on the same terms had been agreed.

## **CHARITY PARTNERSHIP**

The president had held a meeting with GNAAS in early February and had subsequently presented full written details for the committee to consider, the proposal being to proceed with the partnership. **Resolved: Unanimously agreed.** 

Having agreed that should be the case a 'launch' opportunity would now be explored with press coverage. This would be held at DTVA with the helicopter.

Darlington Building Society had been advised of the potential venture and had given their wholehearted support and were prepared to offer donations to the charity of £160 (to celebrate their 160<sup>th</sup> year) each time a club scored 160 or more in the Kerridge and Macmillan Cups in 2016. They would be invited to the launch.

## PRE SEASON MEETING OF CLUBS

There was no change from the last minutes – the event would be held at Teesside University on Wednesday 6<sup>th</sup> April with all clubs to be given full details by e mail in due course.

## **PRESENTATION EVENING 2016**

The date for the presentation evening had been changed to Friday the 18<sup>th</sup> November – all clubs would be advised separately.

The MC for the evening would be BBC Radio Leeds commentator Dave Callaghan, the cricket speaker would be Yorkshire CCC captain Andrew Gale, and the entertainer would be Tom Binns aka Ivan Brackenbury the Hospital DJ, widely recognised as one of the outstanding 'acts' currently on the circuit.

## **TROPHIES**

Following the very generous donation of the Cleveland Cup to the League by the Trustees of the Cleveland League they had offered a further two trophies for use in the NYSD if required.

Having viewed the trophies which resided in the Middlesbrough Town Hall display cabinets, the president felt they would make outstanding additions to the League's current suite of trophies. They had since been collected from MTH and were shown to the meeting.

#### **Resolved:**

Kerridge Cup - this trophy would become the Division 2 championship trophy. Samuelson Bowl - this trophy would become the Division 3 championship trophy. The existing Division 2 trophy would become the Division 4 trophy in 2017.

The ECB had decided that webex conferencing calls would be introduced amongst all 28 ECBPL chairmen to improve communication channels. The first would be held on the 25<sup>th</sup> February at 6.15pm.

As this clashed with the LCC AGM the president asked that one member of the LMC attend to represent the League in his absence. There were no immediate volunteers so an e mail would be sent around all the committee to see if this could be resolved.

# **LEAGUE CRICKET CONFERENCE**

The annual luncheon, AGM and bi-annual meeting would be held on the 12<sup>th</sup> March at Middleton. The president will attend in his role as LCC chairman and he asked that other LMC members consider attending as well to represent the League. As Geoff Cook was due to be elected president at the meeting it was felt important he be supported.

## YORKSHIRE PREMIER LEAGUE MANAGEMENT BOARD

The next meeting of the Management Board is scheduled for 17<sup>th</sup> March at Darrington, the president will attend.

There had been a good turnout by NYSD clubs at the YPL championship launch at York where the draw had been made for the 2016 competition. The leading NYSD Yorkshire club will play the Bradford League champions on 17<sup>th</sup> September at Headingley, the winners of that match going to Abu Dhabi on the 22<sup>nd</sup> October to contest the final.
